# WHC Conservation Certification Version 1.2 Overview

Modifications to WHC Conservation Certification as part of Version 1.2 (v1.2) were implemented in early 2020. The decisions were made by an inter-departmental group of WHC staff that represented corporate, site/program, and communication perspectives as well as the credibility, reviewer and data considerations of the Certification Department.

Modifications were enacted for improved consistency, credibility and reporting capabilities. The most substantive of the changes were the removal of one project type (Other Education) and making two upload fields mandatory. Changes were made to the guidance instructions under some application and scoring questions; these alterations were made for additional clarification and context and are not accounted for in this document.

In addition, a significant accommodation was made in light of the impact of the global coronavirus pandemic. This change temporarily alters requirements and is therefore included in this document.

Each v1.2 modification went into effect between January and April 2020. Applicants who applied in 2020 will be evaluated based on the updates that had been made at the time of their application. The Covid-19 Accommodations were announced April 8, 2020 but are effective retroactively.

## Other Education

Analysis of all the projects submitted under the Other Education project type showed that all Other Education projects should be categorized under the 3 main education project types: Awareness and Community Engagement, Formal Learning or Training.

To improve consistency in applications, scoring, and reporting, Other Education projects are being discontinued. Applicants with existing Other Education projects can gain recognition for their efforts by applying with a different education project type.

## Covid-19 Accommodations

The global impact of the coronavirus pandemic and the public health measures needed to counter its spread will impact many Conservation Certification programs around the world. During this time, maintenance, monitoring, education and other conservation activities may be challenging at best, impossible at worst.

Applications now include series of questions about the impact of Covid-19 on the program. If continuity of a project (management and monitoring, education efforts etc.) is disrupted by the pandemic, the applicant can provide information on the specifics of the disruption (e.g. facility closed) and the dates of these impacts. The reviewers will consider this information so that gaps associated with Covid-19 will not adversely impact an application's score. Applications will be evaluated based on work that was done outside of the impacted time period.

Although accommodations are being made for disruptions in continuity of projects, the base requirements for Conservation Certification remain the same. New programs must still meet the minimum requirement for how long a project has been on the ground and actively monitored prior to applying.
